



Terms and Conditions for LevUp Education Tuition Programmes

Upon enrolment into LevUp Education tuition programmes, the student/parent/guardian hereby agrees to and accepts the terms and conditions stated herein:

Fees Payment

- All fees paid are strictly non-refundable and non-transferable.
- Fees must be paid by the second week of the month.
- By default, monthly payment is inclusive of 4 lessons. Months with 5 weeks may be subjected to additional fees accordingly for the 5th lesson.
- By default, term payment is inclusive of 13 lessons.
- A \$50 late fee will be payable if payment is received after the second week of the month.
- Students who join in the middle of the month will have the fees prorated accordingly based on the remaining number of lessons for the corresponding month.
- All fees are subject to review and revision.

Trial Lesson Policy

- A free trial lesson is available to students who register interest. Fees for the first lesson will be waived if the student does **not** continue with the tuition programme. Should the student decide to continue with the tuition programme, he/she **will have to pay the fees for the trial lesson**.
- On the first lesson, students are encouraged to bring along their last graded examination papers for our teachers' analysis, and writing materials.
- Free trial lessons cannot be used in conjunction with other promotions/discounts [*i.e. discount off first months' fees, attending crash course(s), dual-subject promotions, etc.*].

Payment Modes

- We accept payment by Cash, Cheque and PayNow.
- For cheque payment, please write your child's full name, academic level, subject and contact number on the reverse side of the cheque.

- For PayNow, payment can be made through the invoices sent to the Parent or Student email indicated in the enrollment form.
 - Do indicate the Invoice number 'INV-XXX' to ensure reconciliation of your payment.

Withdrawal Policy

- If a student wants to withdraw from any class, he/she will need to give at least one (1) month's notice before the last lesson.
- No refunds will be given for unused portions of the fees.

Replacement Lessons

- If a student is unable to attend class and is able to produce a valid reason, a replacement class can be scheduled.
- Replacement classes have to be completed within the same month, otherwise it will be forfeited.
- Replacement classes may come in the form of video recordings, consultations or an alternative class session, subject to the discretion of the tutor.
- Replacement classes are subjected to availability, especially on weekends.
- Payment for a full month remains applicable even if the student misses any class.
- LevUp Education reserves the right to reschedule or to cancel a class at any point of time during the term due to unforeseen circumstances.

JC1 Economics Promotion

- The promotion rate of \$240 per month applies to months with 4 lessons. Months with 5 weeks will be priced at \$300 for that month.
- The promotion is applicable for all JC1 students during the promotion period that ends at the end of Term 3 (end September).
- This promotion rate lasts till the end of September 2024. From October onwards the prevailing \$90/lesson rate will resume (i.e. \$360 for months with 4 lessons, \$450 for months with 5 lessons).
